

Dear Mr. Tyler:

On behalf of the Board of the Coalition to Save Sepulveda Basin, I thank you for sending along the fine check from your group, for our Legal Fund. It is most generous and will be helpful.

As I recall our conversations at the meeting of your group which I addressed, your members were concerned that if the flying field were to be located against the bank of the built-up rowing channel, there would be hazards arising from the necessity of having to make steep take-offs, and from other factors related to the height of the channel's high embankment.

We have reason to believe that this problem, at least, is alleviated with the pending agreement by the city not to build the rowing channel. A shorter, smaller lake is probable, located to the west of the proposed site for the flying field but it would not necessitate the built-up wall, as I understand it.

Please let me hear from you if there are any other factors involved, and whether you have had any contact with the area's planners concerning the location of your flying field.

Again, thank you for your kind contribution.

#### Reverie of My First Contest

Like most of you , Ive always been reluctant to enter contests. Probably from fear of failure, or being shown up by better pilots, or whateveronly ones' shrink knows for sure.

Anyway, since I enjoy precision flying and was pushing the club to have a pattern contest, I figured I had better put my money where my mouth was. So I got out the A.M.A. rulebook and figured out what it was that I was supposed to do, and talked to some of the guys about how to do it. Then out to the field with my trusty Falcon 56 and start practicing. Pretty soon the maneuvers were getting easier and lo and

behold my flying was getting better. Then came the fateful day of the contest. With a lump in my throat, (where my stomach was now located) out to the field I went to face the unknown. After paying my entry fee and being duly registered, I sat back and waited for something to happen. Soon they posted the flying rotation and I found my name on the list. What was this!!! My name was at the very top and in addition the wind was blowing from the north and we would have to fly a right hand pattern!!! GULP!!!! That first flight was done in a total stupor. Only the repettition of practice and having Pete Olsen telling me what to do and what to say got me through the first round. Then they posted the scores. I received a 105 score which put me in first place. Hey, All Right, this pattern stuff is easy!!!

Due to the rotation of classes my second flight was the last one.of round two. This gave me lots of time to think (which was a mistake) about how I would have to do better. Well the more I though the more nervous I got. I blew the second flight entirely, and even zeroed the landing when my wing tip caught the weeds at the edge of the runway and spun the plane around. Even at that I scored an 85 which kept me in

first place. But the competition was closing in!!

My third flight was much better and I was getting high scores, but my engine quit during the stall turn and I got zeros for the immelmann turn and the three loops. Still I scored 891, good enough for second

The next day I was more relaxed and scored over 100 for each flight, but could not quite catch the leader. In the end I took second place just missing out by 11 points (338 to 327).

What does all this mean? Well, first any reasonably aerobatic trainer such as the Falcon 56 can compete in the novice pattern class. Second, is to practice, practice, practice. Then flying the contest just like it was practice, and don't try to outdo the competition. The time to perfect and correct the maneuvers is during practice not during the

contest.

Learning how to do aerobatics properly will make a better pilot out of you, because you will be flying with a purpose - not just punching holes in the sky. I still believe that any of our club members could be reasonably competitive, in a contest, if they will practice. It was quite a thrill when they called my name to go and collect a trophy. Lastly I wish to publicly thank Pete Olsen for being my caller. He gave me great assistance and invaluable advice. Thanks Pete!!!!!

P.S. The Kougars have arrived and they will be raffled of at the May meeting. Good And Safe Flying


#### SNACK BAR REPORT


